**Money in Politics**

*The impact of unchecked campaign financing  
and what we can do about it*

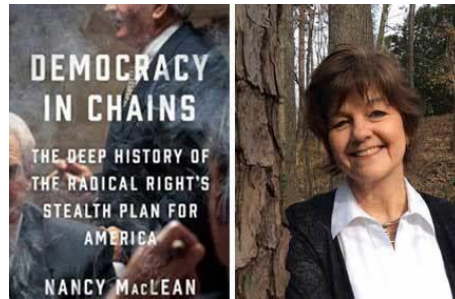

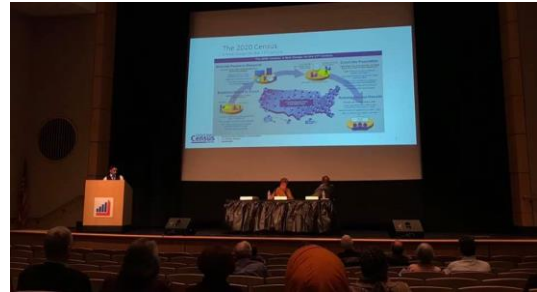
## **LWVAA April 8 Book Discussion**

## 2020 Census Forum Recap

On March 19 LWVAA took a first step in educating the community about the importance of full participation in the census count. Barbara Hunsicker moderated the discussion that began with a presentation by Kent Camino, partnership specialist for the U.S. Census Bureau.

Camino spoke about the Constitutional mandate to conduct the census and its purpose, to:

- Apportion seats in the U.S. House of Representatives
- Conduct redistricting at the federal, state and local levels
  - Data is used to shape the boundaries for state legislative districts, school districts and voting precincts
- Distribute \$675 billion in federal dollars
- Help communities plan for future needs.

He also spoke of the solemn oath taken by all census personnel to maintain the secrecy of census data, punishable by a \$250,000 fine and up to five years in prison. But in the current environment, will that alleviate individual concerns about privacy and potential targeting? The audience probed this issue and the outreach plans to non-English language and other low participation communities.

The Census Bureau believes, based on past experience, that the optimal way to dispel concerns and gain widespread participation is to bond with trusted community agencies via a Complete Count Committee. Forum speakers Larry Chadwick, interim president of the Akron Urban League and County Executive Ilene Shapiro are among the community leaders working to build understanding of the impact of the census. We're delighted that Liz King will represent LWVAA

on the Akron / Summit CCC.

The League is strongly behind robust participation in the census. Fair elections require fair districts based on accurate population counts and communities like our own deserve their fair allocation of federal funds.

## Observer Corps: Green City Council

### Smile With a Service

Acting as Observers for LWVAA, my wife Cathy and I have been going to City Council meetings here in Green for over a year now. It's a good way to get to know our city as well as a great lesson in local Civics. We've also seen firsthand the bitterness that can divide a community when people start talking past each other instead of listening to each other—a microcosm of our nation's ills.



The Council meetings, which begin at 7 PM in Green, are less interesting than the committee meetings that begin at 5 PM. The Mayor and the entire Council are generally present for both/all the meetings, but there is a lot more detail discussed during the committee portion. Something that just occurred to me is that I've never heard a citizen/spectator ask a question during the meetings, and I wonder whether that is because it's not permitted or whether people are satisfied by the discussions. I'll have to ask some Council members about that.

People do speak at the Council meetings, however; one merely has to sign up on a sheet of paper before the meeting in order to get 3 minutes at the microphone. But that's not the same as being able to raise one's hand at the moment something doesn't make sense, or when a Council

member is out of line.

One advantage of going to the meetings is that they are a great opportunity to get petition signatures. During the Fair Districts petition drives, I removed my Observer button several times to get signatures from the Mayor, Council members, and the audience during breaks and after the meetings ended.

Everyone can learn something about his/her community by going to Council meetings, and I hope that when our service as LWVAA Observers is over, Cathy and I will still attend the meetings.

## Legislative Update

Rosanne Winter, Barbara Hunsicker and I attended LWVO's Statehouse Day on March 27. In preparation for meetings with legislators in the afternoon, we spent the morning learning about the bills LWVO is advocating as well as strategies for effective communication with leaders who hold different views.

### Protect and Restore Local Control of Public Education

A paramount duty of the State of Ohio is to provide for an efficient, safe and high quality school system sharing this responsibility with locally elected boards of election that are constitutionally established to provide oversight and direction to the local school district. Ten additional school districts are slated for likely state takeover in the next two years but state takeover in the current three school districts (Lorain, E. Cleveland and Youngstown) has proven to be highly disruptive, frequently leading to dismantling the public system, not strengthening it. Using test scores as the basis for state takeover is questionable given the clear correlation between income and test scores. All of the districts facing takeover have high poverty rates.

ASK IN BOTH HOUSES: VOTE YES on HB 124 to restore local control to schools currently under state control, and VOTE YES on HB 154 to halt the Distress Commission Process.

### Protect Women's Right to Choose

Prohibiting abortions once a fetal heartbeat is detected is unconstitutional and it would effectively prevent patients from getting the care they need from their doctors. This proposed bill does not make exceptions for rape, incest or severe mental illness – all conditions that should evoke compassion, not a one-size-fits-all imperative. Finally, Ohio would be saddled with the costs of defending the bill in courts. Instead the state should focus on reducing unintended pregnancies through increased access to medical care, emergency contraception and comprehensive sex education.

ASK IN BOTH HOUSES: VOTE NO on SB 23 and HB 68



### Protect Free Speech

By liberally expanding definitions of “criminal trespass,” “criminal mischief,” “critical infrastructure facility,” and “economic harm,” SB33 could result in criminal charges and fines for workers peacefully striking at their workplace even if no criminal trespass or property damage occurs. Even acts like advertising events by posting flyers on telephone poles could be considered unlawful. The bill could also be used to penalize whistleblowers trying to keep their communities safe from harm if they believe that a disaster could occur. Acts of vandalism, trespassing and terrorism are already adequately covered and prosecuted under existing law making this bill unnecessary.

ASK IN BOTH HOUSES: VOTE NO on SB 33

### Slow Down Efforts to Reduce Poll Workers

SB 22 would permit boards of elections to reduce the minimum number of poll workers from four to two in multi-precinct polling locations that utilize electronic poll books. We are concerned that this change will result in long lines or otherwise negatively impact voters while acknowledging the goal of using technology to increase efficiencies and the difficulty in recruiting poll workers. Instead of reducing the number of workers, we believe the legislature needs to better incentivize service.

ASK HOUSE OF REPRESENTATIVES: PAUSE SB 22 and improve poll worker incentives.

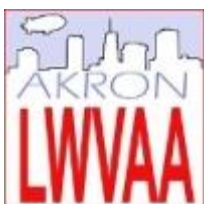
