## A Message From the President

Happy Independence Day!

More than ever we know the importance of the League's mission to encourage engagement and participation in government, increasing understanding of public policy issues, and educating and advocating on those issues.

The deadline for submitting enough signatures for the constitutional amendment to end gerrymandering to appear on this year's ballot was July 5. The Akron League submitted petitions with nearly 1,000 signatures to the Fair Districts campaign to meet the July 5 deadline. Many other Summit County groups including Resistance, the Summit County Progressive Democrats, Indivisible and others were also actively collecting signatures.

The enthusiasm for this effort is truly impressive. Dozens of signature gatherers have visited libraries, festivals, and other public events with great success. However, I have heard that some prospective signers don't know who to call or how to find someone with a petition. Clearly, we need to spread the word about the League and other groups organized to collect signatures.

We also need to continue spreading the word about the meaning of gerrymandering and what it means for Ohioans. The Akron, Hudson and Tallmadge League presidents / conveners wrote a letter to the editor that was published in the West Side Leader the week of June 26. We encourage others to share the message with your networks and through letters to local media.

## Registering New Citizens to Vote

More than 50 new American Citizens were sworn in at the International Institute of Akron's Naturalization Oath Ceremony on Friday June 23 at the Akron Summit County Public Library.

Once again, League members had the privilege of being the first to ask 33 of these newly sworn-in Americans, "Are you a U.S. citizen?" at the conclusion of the ceremony in order to register them to vote. At this time of high-cynicism and tension in the world, it is a rewarding activity to witness the hope of a new citizen in their adopted country.

Also, at a time when there is so much pointed and ugly talk about immigrants, it is refreshing and inspiring to witness how cherished our system is to those who have seen the worst the world has to offer.

## Fair Districts for Ohio

Dear Fair Districts Signature Gatherers, I listened to the Fair Districts update call and learned the following:

- The Fair Districts for Congress campaign intends to file for the 2018 ballot
- Volunteers are encouraged to continue aggressive collection efforts through the summer with a new target date of September 1, 2017
  - Note: 25% of Ohioans change residences every year; the sooner we get the data in, the more likely the validated addresses collected will hold for the Board of Elections' review
- Where do we stand re: collection numbers?
  - A flood of petitions have been delivered to the League and Common Cause in Columbus
  - The staff and volunteers are going through the arduous process of logging signatures into the "VAN" database, determining accuracy of voter data (e.g., are signators registered and do their addresses match Board of Elections data), and scanning all petitions into a separate file for the BOE
  - The team hopes to share an update of number of signatures collected and further collection needs by mid-July
- High enthusiasm for the campaign
- Many ideas were shared for optimizing signature collection
  - Summer events
    - Gathering in advance as a team to have coffee and then fanning out for collection upon arrival
  - Identifying optimal traffic days at libraries and post offices and catching people as they enter and exit
  - Drive-by signing events - identifying a location, date and time and sharing the opportunity on Facebook and other networks
- Creating awareness of how gerrymandering reduces voter choice and leads to representatives who unaccountable to their constituents, is a key element of the signature gathering process
  - To counter opposition, remind potential signers that this is an issue of fairness and both parties use gerrymandering to their advantage. We don't know which party will have the advantage in 2020. We need a bipartisan approach for the future.


